

Auroraneke Cattery Waiting List and Deposit Agreement

We offer our kittens to families in order to receive deposit.

First deposit gets first choice and so on. Deposits can be accepted in the form of cash, check. Kittens must be paid for in full before the kitten leaves the cattery. The terms are found below.

Please **initial** each line to show your agreement with the terms and completely fill out the bottom portion. **By submitting my waitlist deposit and this complete form to Wuzhiyin Sun, Auroraneke Cattery, I confirm the following:**

_____ I understand that my **Waiting List Deposit is \$500**, and it is **NON-REFUNDABLE**. I understand this policy is to ensure that I am fully committed to purchasing a kitten from Auroraneke Cattery.

_____ I understand that if a kitten is not offered to me within one year of my waitlist deposit, my waitlist deposit may be refunded **ONLY** if I have not refused other available kittens that met my kittens description below within the year. If I have refused available kittens that met my kittens description within the year, my deposit will not expire or be returned to me. Instead, I may choose to either forfeit my deposit and be removed from the waiting list or continue waiting for a kitten of my choice and remain on Auroraneke Cattery's waiting list. The waiting list deposit will not expire as long as Auroraneke Cattery's is still breeding.

_____ I understand that I will need to pick my kitten from photos that are provided. I also understand that Auroraneke Cattery cannot hold up the other families in line for me. Photos will be posted of kittens born and until the age of six weeks on Instagram, at that time (5-6 weeks old) pictures will be sent in the order of deposits. **Families will be given 48 hours to choose their kitten.** Upon evaluation of each kitten, the **final price** of kitten will be included with the photos. If shipping is needed an approximate cost of that can be given as well.

_____ I understand that if I neglect to respond to Auroraneke Cattery correspondence about a kitten being offered to me within 48 hours, then he/she may move on to the next in line.

_____ I understand that I have to take possession of the kitten by the date approved by the breeder. If I am to delay in pickup of the kitten I may have to pay an additional DAILY fee of up to \$10.

_____ I understand that the balance needs to be paid in full by the time the kitten is **15** weeks of age unless prior arrangements are made in writing with Auroraneke Cattery.

_____ I understand that if I am picking up the kitten (local pickup) then the final payment can be paid upon arrival and **MUST** be cash or Zelle. If I am using a courier, or cargo shipping to transport the kitten then I must have the final payment to Auroraneke Cattery no later than 7 days prior to kitten departure, this may be paid by Square (+2.75% fee) or by check, but I understand that if my check does not clear the bank by kittens shipping date then kitten will not be sent until check is cleared. If I do not pay the remaining balance by any of the means, or time frames mentioned above, then I will forfeit my deposit.

_____ I understand that the kitten is **not being sold with breeding rights and must be altered around 7-9 months old.**
